The United States Food and Drug Administration (FDA) released the interim final rules on the registration of food facilities and prior notice provisions of the Public Health Security and Bioterrorism Preparedness and Response Act of 2002 (Bioterrorism Act). The new rules come into effect on December 12, 2003.
